JURY QUESTIONNAIRE DIRECTIONS

You are being called as a potential juror in a case that involves allegations of an ongoing war between gangs in [REDACTED]. The prosecution alleges that two gangs, named the [REDACTED], and the [REDACTED], aligned themselves against another gang, [REDACTED]. Specifically, the defendants have been accused of conspiracy to commit murder, and the murder of [REDACTED], and conspiracy to commit murder, and the attempted murder of [REDACTED]. The shootings alleged in this case occurred on [REDACTED] near the intersection of [REDACTED] in San Francisco. Though the murder and attempted murder occurred in San Francisco, this case is brought to trial in [REDACTED] because the alleged conspiracy occurred within [REDACTED]. The defendants in this case are named: [REDACTED]. All of the defendants have pled not guilty to these charges. As jurors, each of you will be asked to determine whether the defendants are guilty of each of the charges at issue in this case. This is not a death penalty case.

As part of your jury duty, the Court is asking you to complete this questionnaire. This procedure is designed to obtain information with respect to your qualifications to participate as a trial juror in this particular case.

It is extremely important that you answer the questions honestly and completely. There are no “right” or “wrong” answers, just complete and incomplete answers. Completing these answers **now** reduces the need for additional or follow-up questioning in court.

This questionnaire is part of the formal jury selection process. It will be reviewed by the Court and by the attorneys during the selection process. **All of the information contained on this questionnaire will be kept confidential. You must answer the questionnaire truthfully under penalty of perjury.** You must also fill it out by yourself and not discuss the questions or your answers with anyone else nor consult with any other person about your answers.

We do not want to embarrass anyone. This questionnaire is being used as an alternative to asking some of these questions in open court. Most people prefer this. But if there is any question that you do not understand or there is any question or subject that you would feel more comfortable discussing in person or in private with the judge and attorneys, you may indicate this on the questionnaire by marking “private” in the space provided for your answer to that question.

If you have trouble reading, understanding, or filling out this form please advise the Court Clerk.

Please do not write on the back of any page and please use the pens that we supply to you to fill out the questionnaire. The questionnaire must be copied so each attorney and the Court have a copy, so please write legibly and darkly on the form. If you need to make further comments regarding any of your answers, you may do so on the explanation sheet attached to the end of your questionnaire.

After completing the questionnaire and turning it into the Clerk you are ordered to return to the courtroom to complete the jury selection process.
